Cal's Market Read

Overnight, corn slipped about 8 cents; beans slipped about 2 cents; and wheat slipped about 10 cents.

Recent trend, over the last 4 sessions, corn has eased and beans have firmed. That is the backdrop your cash bid is moving against.

Here is our read on why grain slipped overnight. None of today's headlines, from the Iowa On-Farm Forestry Field Guide to the John Deere right to repair settlement, are price movers, and no USDA report is on the calendar. So we would not hang this modest 8 cent corn, 2 cent bean, 10 cent wheat pullback on any one cause. Our best read is broad, quiet selling with no fresh demand news to lean on.

Stocks are steady going into the open, S&P; futures close to flat. A calm Wall Street is what your banker likes to see, it keeps the rate and input-cost backdrop behind your operating note quiet for another day.

Decision Delivered

Your decisions for today and the week ahead:

- Paperwork: FSA crop acreage reporting is due July 15 for spring planted crops. That is in 6 days, so prep now, get your planted acres by field, planting dates, and any prevented planting ready for your county Farm Service Agency office now, a late certification can put your farm program payments and crop insurance at risk.
- Standing reminder: Hot, dry stretches raise spider-mite pressure on field edges. Scout the south and west borders of soybeans and corn.
- Reminder: Dig an 8-inch root cube on a few plants in continuous-corn fields to confirm your rootworm trait is holding, and rescout soybeans for early defoliators.

Farm context: Skala Farm, Steele County demo (synthetic data bed; family heritage acres are the reference point). Real intake replaces the synthetic figures the moment you send your farm shape, acreage by field, and bin inventory.

What to Watch Today

- Field window: any rain risk eases by 6 AM, then the working day looks dry enough for field passes. Check the wind first.
- Market watch: corn down about 8 cents, beans down about 2 cents going into the day. Wheat down about 10 cents. Watch the cash bid at your elevator.
- On the wire: John Deere Settles FTC Antitrust Suit, Granting Farmers 10-year 'Right to Repair' (see Cal's News Desk below).

1. John Deere Settles FTC Antitrust Suit, Granting Farmers 10-year 'Right to Repair' John Deere just agreed to a major settlement with the Federal Trade Commission and five states, Michigan, Illinois, Arizona, Minnesota, and Wisconsin, ending a lawsuit that claimed the company boxed farmers into an expensive repair monopoly. For the next 10 years, Deere must give farmers and independent mechanics the same diagnostic software, manuals, and tools its own dealers use, all on fair and reasonable terms, plus pay \$1 million toward state legal costs. The order, still pending approval from Judge Iain Johnston in Rockford, Illinois, also bars dealers from retaliating against do it yourself customers and forces Deere to release any new repair tools to the public once more than half its dealers get them. For anyone who has watched a locked ECU stall a tractor in the middle of harvest, this is a real shot at fixing your own machine without waiting weeks or paying premium dealer rates, and the FTC says it should lower costs across the board. 2. No-Till Cropping & Business Insights The 2025 No-Till Farmer Operational Benchmark Survey is being promoted here as a deep online resource for no-tillage practices, with the pitch that a single good idea can pay back a subscription many times over. The piece also spotlights an advanced XPR concave system that threshes all crops with one set, cuts rotor loss, and delivers cleaner grain samples and better grain quality. Titan International gets a strong plug too, described as one of the largest North American makers of wheels, tires, and undercarriage products for farm, construction, forestry, mining, and other off road equipment, backed by a worldwide dealer network. It matters because these tools and suppliers all point toward the same goal for your operation, namely better productivity and profitability through smarter no-till decisions and reliable equipment. 3. Agriculture industry urges USTR to make exemptions to proposed forced labor tariffs At a Wednesday hearing, farm and food groups pressed the U.S. Trade Representative to reshape a proposed Section 301 tariff of 10% to 12.5% aimed at 60 nations accused of using forced labor. U.S. Cattlemen's Association policy director Jenna Stanton pushed to scrap the exemption on all bovine products, warning that Brazil has at least 21 cattle operations on its slavery blacklist and that cheap, tainted Brazilian beef can even sneak in rerouted through Argentina. She also flagged that Trump's February order already lets 80,000 metric tons of tariff-free Argentine beef in each year, citing record low U.S. cattle herds. Coffee interests joined too, with the National Coffee Association noting coffee cannot be grown domestically yet adds over \$343 billion to the economy, so decisions here could reshape prices and competition landing right next to honest American producers. 4. US strikes Iran as Trump says truce 'over' President Trump has declared the truce with Iran "over," and on Wednesday the U.S. military resumed its air strikes against the country. The stated goal is to further cripple Iran's ability to disrupt maritime traffic in the region, a threat that has rattled global shipping lanes. This marks a sharp escalation after a period of calm, signaling that Washington is willing to use force again to keep sea routes open. For anyone watching grain exports and fuel prices, renewed conflict near key waterways is worth following closely, so read the full report for the details. [Read the full article](#). 5. Comprehensive On-Farm Forestry Field Guide for Iowa Iowa State University Extension has released a free On-Farm Forestry Field Guide for Iowa, aimed at helping farmers and landowners turn neglected trees into an asset for their operations. Extension forestry specialist Billy Beck, who built the guide with Iowa Learning Farms and input

from professional foresters plus two dozen farmers, notes the state has lost roughly 4 million acres of woodlands over the past two centuries. The guide walks landowners through building a forest plan, then covers the practical next steps like species selection, planting, and pruning, with links to detailed how-to resources. Beck argues that trees along pastures, waterways, and windbreaks can boost soil, water, and crop health while adding timber income and property value, so it is worth downloading the free copy or requesting a pocket-sized print version. 6. 2026 Dairy Farmers of Wisconsin Election Results Wisconsin's dairy leadership just got a shakeup, with state regulators at DATCP certifying the results that seated a fresh slate of nine producers to the Dairy Farmers of Wisconsin board for three year terms starting July 1, 2026. Eleven certified candidates fought for those nine seats across nine districts before voting closed on May 22, giving farmers a real say in how their checkoff dollars get spent. The same roundup notes that World Dairy Expo has hired Michelle Brokish of Spring Green as its new Sponsorship Manager to court the hundreds of companies and farms backing the world's top dairy show. It also flags that half of this year's Alice in Dairyland finalists hail from UW River Falls, a sign of where the next generation of dairy promoters is coming from. [Read the full article](#). No-Till Highlights: July 9, 2026 This week's No-Till Farmer roundup gathers standout field stories, starting with Convoy Dairy in Van Wert County, Ohio, where Harting Farms no-till plants corn silage the same day oatlage comes off, running a 54-row John Deere DB90 planter on 20-inch rows behind a 9570R on LSW tires with a Gator-mounted Yield 360 Sprint feeding fertilizer to cut downtime. Air quality specialist Dr. Frank Mitloehner talks with Illinois hog farmer Gary Asay about a closed-loop, no-till operation where pig manure feeds the soil, earthworms replace tillage, and the ground grows the grain that feeds the next round of pigs. K-State agronomist Chuck Rice and Hayden Guetterman cover soil health gains from cover crops, Tennessee farmer Matt Griggs shares 10 plus years of no-till water infiltration data while testing an EarthScout moisture sensor, and Pennsylvania grower John C. Johnson explains why saving time drove him to no-till across nearly 1,000 acres of corn, wheat, and soybeans. For a farmer weighing inputs and hours in the cab, these real-world results on soil moisture, fertilizer efficiency, and labor savings show how no-till and regenerative practices are paying off across very different operations. 9. A Tale of Two Regions: Indiana's Split Planting Season Leaves Farmers Hoping for a Strong Finish This Fall Two Indiana farmers had opposite springs this year, with C.J. Fleenor in southwestern Orange County finishing all his corn and soybean planting by around April 28th, a personal record, while Don Wyss near Fort Wayne sat stuck in the barn as rain, frost, and cold locked up the north. Statewide the crop looks tough with 62 percent of corn and 64 percent of soybeans rated good to excellent, but those numbers hide a split state, since the south now sweats a hot, humid July that could unleash tar spot and southern rust while the north's late heat rescued drowned fields just in time for pollination. Fleenor worries whether cash strapped growers can even afford fungicide, while Wyss plans to spray his corn and protect a yield that finally caught up. It matters because this is the same volatile, hyper local weather roller coaster hitting the whole Corn Belt, and it shows how two neighbors 215 miles apart can face totally different odds heading into fall harvest. 10. News Wrap: Judge orders \$5.8M paid to E. Jean Carroll in Trump sex abuse, defamation case A federal judge has ordered more than \$5 million in damages released from escrow to writer E. Jean Carroll, money tied to a 2023 jury verdict that found President Trump sexually abused her in the 1990s and later defamed her, though Trump's lawyers have already appealed to block the payment. In other news, former Wisconsin judge Hannah Dugan dodged prison but must pay a \$5,000 fine for helping a Mexican defendant try to evade immigration agents, while

former Chicago mayor Rahm Emanuel used a Tel Aviv University speech to urge the U.S. to end unconditional support for Israel and back a 23 state solution. On the economy, the International Monetary Fund cut its 2026 global growth forecast to 3 percent and warned inflation could near 5 percent as the war in Iran spikes oil prices by roughly 32 percent, and the Dow fell nearly 600 points on the day. The wrap also notes a wobbly former Pfizer high rise in New York City has been stabilized after crews found buckled columns, and actress Louise Lasser of "Mary Hartman, Mary Hartman" has died.
