Cal's Market Read

Overnight, corn added about 4 cents; and beans added about 5 cents.

Recent trend, over the last 5 sessions, corn has firmed and beans have firmed. That is the backdrop your cash bid is moving against.

Here is our read on why. Cutting the other way, demand still reads firm per Tri-State Neighbor: Understand stress during corn reproductive stages. Honest truth, the tape does not hand us one clean reason today, so take this as our best read, not gospel.

Stocks point higher into the open, S&P; futures up about 0.2 percent. A firmer tape eases the borrowing and input-cost mood your lender watches, though it does not move your cash bid by itself.

What to Watch Today

- Rain watch: through the workday the best rain chance is around 11 AM (48%). Time spray and field passes to the drier hours, and check the wind first.
- Market watch: corn up about 4 cents, beans up about 5 cents going into the day. Watch the cash bid at your elevator.

1. Senate Farm Bill Stalls Over SNAP Dispute A one-vote margin, 10 to 11, sank the Senate Agriculture Committee's farm bill on Thursday, with the whole fight coming down to how fast states must start sharing SNAP costs, Democrats wanting a two-year delay and Republicans offering just one. Chairman John Boozman warned that the stalemate is "holding hostage our farm community," noting livestock is one of the poorest industries in America right now and that rural America pays the price. Even so, the committee did pass amendments to move Food for Peace permanently to USDA and to let SNAP buy hot rotisserie chicken. American Farm Bureau's Zippy Duvall and Farm Credit's Christy Seyfert are both urging senators back to the table, warning this may be the last shot this year at a five-year bill that would strengthen crop insurance, expand credit, and modernize FSA loans. 5. Not Every Spot Is the Same: Identifying Corn Leaf Diseases Accurate corn disease identification drives smart fungicide decisions, since foliar diseases cut yield and silage quality by robbing leaves of photosynthesis, inviting stalk rot and lodging, and killing plants early. Penn State scouts warn that gray leaf spot and northern corn leaf blight thrive in wet, humid weather, hitting no till and continuous corn hardest, while emerging threats like southern rust and

bacterial leaf streak are easy to mistake for other problems. The guide walks through telltale signs, tar spot shows shiny black stromata you cannot rub off, northern corn leaf blight makes cigar shaped lesions up to six inches long, gray leaf spot forms rectangular gray lesions along the veins, and southern rust packs bright orange pustules only on the upper leaf surface. Getting the diagnosis right matters because look alikes such as common rust versus southern rust call for very different management, and disease pressure often climbs during grain fill just as your last fungicide starts wearing off. 6. Conservation Ag Champions: Unrewarded Heroes of Sustainable Farming in Developing Countries

Farmers who quietly abandon the plow and stop burning their residue may be the most overlooked leaders in global agriculture, especially across fragile, drought-prone regions like Iran. The article calls them Conservation Agriculture Champions, and it lays out three core principles they live by, minimal soil disturbance through no-till, permanent soil cover from crop residue, and diverse crop rotations. It walks through six big payoffs, protecting soil, saving water and easing pressure on aquifers, ending residue burning that fouls the air and releases carbon, building resilience to wild weather, proving that ditching tillage can hold or even raise yields while cutting fuel and labor costs, and spreading know-how farmer to farmer. The reason it matters is trust, because in these communities neighbors believe a fellow farmer's field far more than any scientist or government agent, so these champions turn their own acres into open-air classrooms that convince skeptics to change. 7. Trump signs executive orders to curb birthright citizenship and 'birth tourism' Trump signed two executive orders Thursday at the White House aimed at restricting birthright citizenship and what he called "birth tourism," claiming hundreds of thousands of people were "buying their way in" to gain citizenship for their children. The orders would deny automatic citizenship to children of some foreign diplomats, alien enemies including declared terrorist group members, and mothers who deceptively enter the country to give birth, while also targeting surrogacy used for that purpose. Deputy chief of staff Stephen Miller said the administration was leveraging the Supreme Court's June ruling to expand who is ineligible under section 215A of the Immigration and Nationality Act, insisting nothing in the orders conflicts with the court. Legal experts expect the orders to face challenges under the 14th Amendment, which guarantees citizenship to nearly every child born in America, especially over the provisions covering U.S. territories, where only Congress can change citizenship rules. 8. Understand stress during corn reproductive stages The Minnesota corn crop is about a week ahead of normal and currently has adequate moisture but limited precipitation or chances for precipitation means things are drying out. Fortunately, the temperature conditions are expected to be cooler. Ryan Miller, University of Minnesota Extension Educator for Crops; Jeff Coulter, University of Minnesota Extension Corn Agronomist; Brad Carlson, University of Minnesota Extension Educator, Nutrient Management and Water Quality; and Dean Malvick, University of Minnesota Extension Pathologist, Field Crops; all contributed to the article. 9. Stalled farm bill spotlights ag woes and state budget strain Senate Agriculture Chairman John Boozman saw his farm bill collapse Thursday on a 10 to 11 party line vote, undone partly by the health absence of Sen. Mitch McConnell and a surprise no show by Sen. Tommy Tuberville, since committee rules bar proxy yes votes and treat ties as defeats. Boozman is holding the markup open and says McConnell, now home recovering, could return by mid September to break the deadlock, while the real fight is over a SNAP provision in the One Big Beautiful Bill Act that forces states with 6 percent error rates to help pay benefits starting Oct. 1, 2027. Democrats led by Sen. Amy Klobuchar want a two year delay instead of the one year Republicans offered, arguing states like Minnesota need time and fairness, though both sides agree the bill holds wins like year round E15 ethanol sales. This matters because Boozman warns that without an updated farm bill and higher farmer loan limits, bankers expect 20 to 25 percent of farmers to be lost in the next two to three years amid the worst farm economy in decades, and the panel did advance bipartisan amendments including Sen. 10. Opinion: How one state's poultry lawsuit became a warrant-free search of another state's farms Back in 2005, Oklahoma sued six large poultry companies, including Tyson, over pollution in the Illinois River Watershed, essentially using the lawsuit to control Arkansas farmers it could not regulate directly. After sitting idle for 20 years, a district court in late 2025 handed down a sweeping ruling that appointed a "special master" with power until 2055 to search land, take soil samples, cut contracts, and refer noncompliant farmers for prosecution. Facing that threat, the poultry firms began cancelling contracts with their small "contract growers," many of whom depend on chicken litter as fertilizer, raising fears of an economic and public health crisis across Arkansas farm country. The companies eventually settled by swapping the special master for a seven year "auditor" doing nearly the same job, but their fine ballooned from a few hundred thousand dollars to a staggering \$40 million.
